Public Site Record Filters

Animal Shelter

Must have: Ticket Number, Intake Date

Must NOT: Have Disposition Date, Marked as EXCLUDE from Website

Complaint Card History

Must be: Completed (no current cad)

Must have: Received Date, Completed Date, City, Nature, and Disposition

Must Not Be: Current Hold Call, Canceled Call, Restricted From Public,
Nature cannot be marked as Exclude from Website.

Disposition cannot be Marked as Exclude from Website

Fine Cost Dockets

Must Have: Court Code, Court Date, Docket Number, Payment Start Date, Charge

Must Have: Defendant City populated, Defendant cannot be marked as Deceased

Must Not Be: Disposed, Excluded From Website, Bankrupt

Court Code Must not be marked as Exclude from Website

Charge Code Must not be marked as Exclude from Website

Open Docket Amount Must be 100.00 or greater

Record will also be exclude "IF" Payment Start is greater than "Today"

Incident Reports

Must Have: Case Number, Report Date, Case Number, City, Reporting Officer, Approved Date, Department Code

Must Not Be: Excluded From Public, Restricted To Detective, Under Investigation, Investigated By Outside Agency, Marked For Expungement, Expunged, Locked, Information Only , Marked as Juvenile Involved

Reporting Officer is marked as exclude from website (ex: Undercover, Task Force)

Department Major of Reporting Officer not marked as exclude from website

Reporting Department not marked as exclude from website

Booking

Must Have: Intake Date, Intake Agency Responsible, Inmate Classification, Cell Location

Must Not: Have Release Date, Booking marked as Exclude from website

Intake Agency/Department not marked as exclude from website (ex: US Marshal/Feds)

Inmate Classification not marked as exclude from website (ex: Federal Hold)

Cell Code not marked as exclude from website (Ex: CELLS in POD E-Echo (ICE holds))

Notes: The Must have is to give your agency time to get the inmate completely booked it and define for us a good/complete record.

Registered Offenders

Must Have: Registration Date, City Populated

Must Not: Marked as In-Active, Restricted From Public, Excluded from Website, Marked as Work Only Registration

Warrants

Must Have: Issued Date, Warrant Number, Court Code, Paper Type Selected, Charge

Must Not: Be Completed, Marked as exclude from website

Court Code not marked as exclude from website (Ex: Juvenile Court)

Paper Type Code not marked as exclude from website (Ex: Juvenile Bench Warrant)

Charge not marked as exclude from website

Most Wanted

Must Have: Include On Website, Cleared Date is Empty

Missing Persons

Must Have: Include On Website, Cleared Date is Empty
