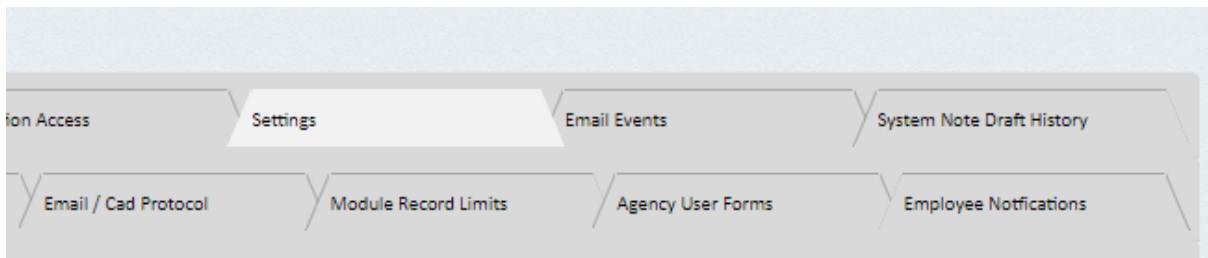

Review all settings that start with DATA-QUALITY and turn on the items you want validated.

There are a few like **DATA-QUALITY-OFFENDER-CHECKS** that are required to be active/Yes to make other validations work.

Example: There are settings to test if the Arrested Offender has at least one Charge.

It will not test for that unless **DATA-QUALITY-OFFENDER-CHECK IS Y-YES**.

In incidents to the right of the IBRS Validate Button is the new Data Quality Check Button.

Please note: These tests are separate from IBRS Validation.

This is strictly a Data Quality Check to ensure the Report is complete. This does not mean it has failed the IBRS Validation.

Shown Below is an Example of a Victim's Data Quality Check:

To get detailed contact information such as the Phone Number, Address, etc. of a Victim is not normally types of information that is required for IBRS submission, however, it is a part of the Data Quality Check that will be performed by the Supervisors.

Another Example is if you turn on the Data Quality Check for Evidence it will verify that all pertinent data such as Owner, Submitted Date/Time/By which are requirements for importing property into the Evidence Module.
