Company Setup – P.R.E.A. Settings

INMATE-PREA-ASSESSMENT-NEXT-REVIEW-DAYS – Default is 0 Days. If used will auto forecast Next Review Data based on Assessment Date + Day Value

INMATE-PREA-ASSESSMENT-NEXT-REVIEW-DAYS-SENTENCED – Default is 0 Days. If used will auto forecast Next Review Data based on Assessment Date + Day Value, if the inmate is Sentenced.

INMATE-PREA-AUTO-MARK-ON-NEW-BOOKING – Default is Yes. If yes will mark New Bookings as needing a P.R.E.A. Assessment made.

PREA ASSESSMENT KNOWN VICTIM - Used to notify when new P.R.E.A. Assessment is scored as a Known Victim.

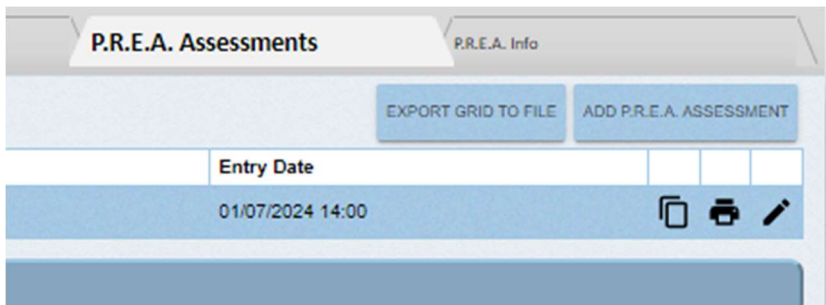
PREA ASSESSMENT KNOWN PREDATOR - Used to notify when new P.R.E.A. Assessment is scored as a Known Predator.

PREA ASSESSMENT RE-ASSESSMENT - Used to notify when new P.R.E.A. Re-Assessment is created

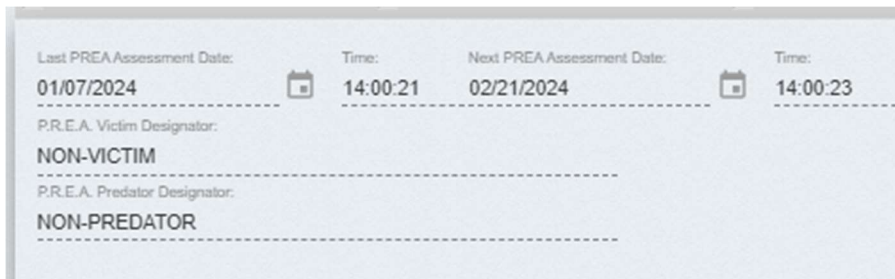
PREA REPORT-FILE - Used to notify when a new PREA Jail Incident is filed.
