

Concerns Assessment Questions

You do not have to have UCR, Offender, or Victim filled in on the report. Those pieces of information can be manually entered so that the officer can more quickly enter this form. However, if that data is populated, iSOMS will attempt to auto-fill **Offense**, **Offender**, and **Victim**. If iSOMS does auto-fill, the options can be overwritten by the officer.





Settings

Settings

LETHALITY-ASSESSMENT-ATTEMPT-TO-AUTO-FILL – Default Yes. If Yes, iSOMS will attempt to auto-fill the **Offenses**, **Victim**, and **Offender** fields from the 1st listed record in each tab.

LETHALITY-ASSESSMENT-DEFAULT-AS-NOT-ASKED – Default Yes. If Yes, iSOMS will put all answers' default as *Not Asked*.

LETHALITY-ASSESSMENT-HOTLINE-NUMBER – No default. This number, at report generation / print time will print as the Hotline Text/Number from this setting.

LETHALITY-ASSESSMENT-REPORT-HEADER - No default. This number, at report generation / print time will print on the header from this setting.

LETHALITY-ASSESSMENT-SUBMITTED-NOTIFY-SUPERVISOR – Default Yes. If Yes and the assessment has a **Final Disposition**, iSOMS will email the Employee's Supervisors a link to this incident with the assessment details.

Email Event

The **Lethality Assessment** has an email event for when you click **Email** on the report screen.







An officer may trigger the protocol referral, if not already triggered above, as a result of the victim's responses to the below question, or whenever the officer believes the victim is in a potentially lethal situation.

If you want to email the report, click **Email** and add the new **Email Group** you created earlier. iSOMS will email a PDF of the report to each email account in the email group, both the iSOMS employees and the outside emails you added before.

The FBI order to questions #2 and #5 are swapped. In order to switch this (such as if you want to use the FBI order), you can use **Maintain Files**.



Click **RECORDS → ADMIN → INCIDENT REPORTS**

In the upper right, click:
MAINTAIN FILES → LETHALITY ASSESSMENT → LETHALITY ASSESSMENT QUESTIONS.
Now edit code #2 and code #5. Change both the **Code** and **Code Ranking** by swapping 2 and 5.
This will set the report to have the same order as the FBI ordering of the assessment questions.
